Cite to show your research, credit authors, and help readers find your sources.

"Documentation is the means through which scholarly conversations are recorded, and the specifics of those conversations matter." (MLA Handbook, Fitzpatrick)

- Author.
- 2 Title of source.
- 3 Title of container,
- Other contributors,
- ⁵ Version,
- 6 Number,
- Publisher,
- Publication date,
- 9 Location.

Author. Last name, first name (or first initial). More than 3—et al., or spell out. No stated author: Begin with title.

Title of Source.

- Book, website: *Title.* in italics.
- Article, webpage, part of a larger collection: "Title." in quotes.

Title of Container, If the source is a part of a larger whole, the larger whole is the container (journal, TV series, website) *title* in italics.

Other Contributors, Precede name with a description of the role: adapted by, directed by, translated by, edited by.

Version, Use if the source carries a notation of version: edition, unabridged, director's cut.

Number, Volume, issue, sequence, or episode/book of a series.

Publisher, The organization primarily responsible for making the book, film, website available to the public.

Publication Date, If more than one date, cite the date that is most relevant to use.

Location.

- Print works: Page number (p.) or range of pages (pp.)
- Electronic works: URL or DOI (preferred for article)

no author stated	E-book, ALA Neal-Schuman, 2016. EBSCOhost eBook Collection. Beowulf. Translated by Alan Sullivan, edited by Sarah Anderson, Pearson, 2004.

Chapter in a Book (Part in a Series)

Format	Author(s). "Title of source." [chapter title] <i>Title of container, [book title]</i> Other contributors [Editors], Number [chapter, episode], Publisher, Publication date, Location [pages].
Example	Alter, Alan. "The Ingredients of Behavioral Addiction." Irresistible: The Rise of Addictive Technology, Penguin Press, 2017, pp 27-32.

Entry in a Reference Source

Format	Author(s). "Title of Source" [entry]. <i>Title of container</i> [encyclopedia], Other contributors [editors], Version [Edition], Number [Volume], Publisher, Publication date, Location [pages, URL, DOI]
Examples	Spencer, Johnathan. "Marxism and Anthropology." Routledge Encyclopedia of
	Social and Cultural Anthropology, edited by Alan Barnard and Jonathan
	Spencer, Second edition, Routledge, 2010, pp.446-449.

Article in a Journal or a Newspaper

Format	Author(s). "Title of source." [article title]. <i>Title of container</i> , [journal title] Number [volume, issue] Publication date, Location, page, URL, DOI (preferred).
Example	Lever, Aldo. "Liberalism, Democracy, and the Ethics of Voting." Politics, vol.
	<i>29,</i> no. 3, 2009, pp. 223-227. doi:10.1111/j.1467-9256.2009.01359.

Page from a Web Site

Format	Author(s). "Title of source." [page name] Title of container, [website name] Publication date, [if available] Location, [URL if the reader can't easily find it], Date of access. [if no publication date]
Example	Roser, Max, and Estebgan Ortiz-Ospina. "Literacy." Our World In Data, 20 Sep 2018, ourworldindata.org/literacy.

Video or Image on a Webpage (e.g. YouTube)

Format	Contributor(s), contributor's role. "Title of source." [video/art title]
	Title of container, [website] Publication date, Location [URL].
Examples	University of Chicago. "European Cartographers and the Ottoman World,
	1500—1750" [Video file]. YouTube, 12 Dec 2007, Retrieved from
	http://www.youtube.com/watchz.

- Use the title **Works Cited** centered at the top of the page for your bibliography
- Alphabetize by author last name, use a hanging indent, and double-space
- End Author and Title of source in a period. String together the other elements with commas and end the entire citation with a period
